This Introductory Free Silver Membership (1 Month) offers Rewards & Rebate and Cash Back Vouchers to the new Members to redeem without the cost of a Membership fee.

Options:

- a)Sign up for a **Free Silver Membership Introductory offer (1 Month)**. Earn Rewards & Rebate and Cash Back Vouchers for 1 month.
- b) After 1 Month Return as a Bronze Member (Free Membership) and still benefit with Reward and Cash Back Vouchers as part of our Reward for Loyalty Program.
- c) Or Pay for a Membership Package and benefit with Reward/Rebate and Cash Back Vouchers as part of our Reward for Loyalty Program.

Trial Membership (Silver Member)

(k) Cash Back Vouchers means Vouchers on offer to Reward Members who buy Specials whereby a % or \$ Cash Back Voucher applies.

Cash Back Vouchers are issued at the End of each Quarter

Example: March 31st, June 30th, September 30th, December 31st.

- (L) Managers Special means Goods that are on Special (rebates do not apply) at Special Pricing for a Limited time. This is indicated on the Description of goods.
- (m) Freight means the supply of goods from the Supplier to farmsupplies.net.au
- (n) Delivery means the supply of goods from farmsupplies.net.au to the Customer.
- (o) Members Special means Goods that are on Special but may be offered to specific members only. This is indicated on the Description of goods.

2.0 Customer Orders, Shipping and Delivery.

The information on the farmsupplies.net.au website is regularly updated. farmsupplies.net.au reserves the right to alter or change the prices listed in this website without prior notice.

An order placed via this website is considered to be treated as a sales order and is only excepted once we acknowledge and return via email order confirmation that the order is accepted and shipment of goods is in place.

It is your responsibility to confirm the accuracy, reliability, completeness and currency of the information in this site.

It is farmsupplies.net.au's right to change or alter the price of ordered goods if the price was found to be incorrect at the time of the order or if the items on order are unavailable for shipment. In some instances, customers may be contacted and asked to confirm if the ordered goods are still required at the altered price or in the case of items that are unavailable a substitute item be ordered in its place.

Delivery Quotes and Invoicing Procedures

We have many transport companies who can deliver direct to your address or by a freight depot in your nearest town or if you like you can pickup.

Once you place your Sales order,

we may organise pickup or a Delivery Quote based on your instructions.

Procedure

1) Advise us you will Pick up.

Place your Sales Order.

In this case in your online Sales order tick the box, "I will Pickup",

Pickup obviously doesn't incur delivery fees, so you are then asked for payment, which we will process accordingly.

We will then supply a Sales Invoice.

We then organise the Sale for Pickup.

2) Advise us to get a Delivery quote.

Place your Sales Order.

In this case in your online Sales order tick the box, "I require a Delivery Quote",

We then supply a **Delivery Quote**.

At this stage the order is still a Sales order, until we get confirmation you are happy with the Delivery Quote and wish to proceed.

Once you confirm approval, we then asked for payment, which we will process accordingly Once paid we will then supply a **Sales Invoice** and a separate **Delivery Invoice** (Based on the Delivery Quote)

We then organise the Sale for Delivery.

Shipping

farmsupplies.net.au will use reasonable endeavors to supply the goods on the delivery days made known to the customer and in the quantities specified in the order.

Orders cannot be delivered to post office boxes. farmsupplies.net.au requires that you have your order delivered to an address where someone will be present during business hours to receive, sign and unload the delivery.

Processing

farmsupplies.net.au will normally process your order within 5 to 7 working days (or earlier) of payment being received. If there is a problem fulfilling your order (e.g. stock not available in the warehouse), we will notify you within this period to let you know. When your order has been picked and packed, you will be advised via email. If you live in remote areas delivery could take up to 7 additional working days from this date, dependent on the location.

Deliveries outside of Australia are not currently available.

Some Definitions

- (a) Customer Order means the Supply of goods/service to the Customer, or the placement of an order by the customer will be on these terms. Acceptance of the goods/service or placement of an order by the customer will be deemed to the acceptance of these terms.
- (b) Customer or Membership orders will be accepted upon farmsupplies.net.au being able to purchase the goods on request. farmsupplies.net.au has the right to refuse the customer/Membership order.
- (c) It is farmsupplies.net.au 's right to change or alter the price of ordered goods if the price was found to be incorrect at the time of order or if the items on order are unavailable for shipment. 3.0 Pricing and Payment.

- (b) Unless otherwise required by farmsupplies.net.au , all invoices must be paid in full to receive Reward and Rebate vouchers.
- (c) The List Price of goods is the prevailing price at time of delivery. farmsupplies.net.au may alter pricing at any time without notice. We reserve the right to sell items which excludes rebates to members. We reserve the right to sell items on special to specified Members Only.
- (d) Quotations are open for acceptance within a period stated in them, or when no period is stated, within 7 days after that date.
- (e) In the case of Members using Payment to their Trading Account

farmsupplies.net.au may charge an Administration Fee on any outstanding amount at a rate of \$1.5% per calendar month compounding monthly, from the due date until payment is received in full (subject to change at farmsupplies.net.au discretion).

Any expense costs or disbursements incurred by farmsupplies.net.au in recovering any outstanding moneys, including all reasonable debt collection fees and solicitors cost and legal disbursements shall be paid by the customer.

If it becomes necessary to recover underpaid debts by a debt collection agency or institute legal proceedings to recover underpaid debts to farmsupplies.net.au, all rebates showing on unpaid invoices become null and void and the total list prices showing becomes payable.

farmsupplies.net.au shall be entitled without notice to terminate any credit arrangement with the customer in the event the customer defaulting in any of the terms and conditions contained in this agreement or for any other reason which farmsupplies.net.au need not make known to the customer. (g) There is no obligation by farmsupplies.net.au to use the "suggested Retail Price' quoted in sales Catalogues, advertisements, or brochures. A Price List or Product Catalogue from Suppliers is not an offer by farmsupplies.net.au to sell any goods appearing in that list or catalogue, nor is it an offer to sell such goods at the prices specified in that price list or catalogue.

The farmsupplies.net.au is free to use this price or set a retail price they wish.

(h) If a Member decides to terminate their membership, they must notify farmsupplies.net.au . If the Membership account is paid in full, then a rewards voucher may be set up to reimburse (credit) remaining Membership Service Fees. 4.0 Delivery.

- (c)If farmsupplies.net.au fails to deliver or make defective delivery of goods under these terms, the customer will not be entitled to cancel any other delivery.
- (d)Special supply agreements upon signed agreement in writing does not allow the customer to cancel any further delivery. If any promotional line is offered or received then the full supply of goods will be delivered immediately. The promotional line remains the property of farmsupplies.net.au until all conditions are meet by the Supply Agreement.

Containers and Pallets (Chep)

(a)Any pallets or containers used for the delivery or storage of the goods will remain the property of farmsupplies.net.au . The Customer must promptly return or exchange the pallets and containers in its custody or reimburse farmsupplies.net.au the cost of replacement or repair of lost or damaged pallets or containers.

(b)Any Deposit charged will be credited in full at the time the container is returned to farmsupplies.net.au provided it is in good condition and good order.

Freight methods

Registered Australia Post with tracking using the Australia Post Express Post Service. Excludes Heavy Items.

Quote - Courier

farmsupplies.net.au uses Star Track Express or Toll Priority. We courier items like fencing wire, farm gates and water tanks.

Please call us if you would like us to check if a courier will come to you. All courier services require a signature upon delivery.

Quote - Heavy Items

We classify heavy items as products that are over 15Kg or items that cannot be delivered by the Registered Australia Post service. Our customer service team will quote you with delivery options and prices.

We will let you know what the additional freight charge amount is and your delivery method options.

5.0 Warranties.

(a)The customer warrants that it understands the nature and the characteristics of the goods, including their innate hazard and toxicity and is familiar with all the information available it.
(b)If it is proven to farmsupplies.net.au's reasonable satisfaction that the goods do not comply with the Manufacturer's warranty farmsupplies.net.au will seek compensation on behave of the customer. The manufacturer will at its cost and at its option, either replace the goods with the same or equivalent product, or pay the cost of replacement with the same or equivalent products, but otherwise subject to the provisions of these terms, farmsupplies.net.au accepts no liability to the Customer or the third party.

(c)The Manufacturer's Warranty does not comply unless the goods have been properly handled, used, maintained and stored, the defects occur within 24 months of importation or formulation of the goods or within 12 months of their delivery, whichever period first expires. farmsupplies.net.au is notified in writing within 7 days of the alleged defect first coming to notice of the customer and the customer returns the goods to farmsupplies.net.au.

6.0 Limitations.

Limitations

(a)farmsupplies.net.au will not be liable for any loss, damage or injury including consequential loss (such as loss of profits and loss of opportunity), arising from the condition, supply or use of the goods or otherwise, whether or not caused by farmsupplies.net.au Group's negligence.

7.0 Indemnity.

Indemnity

- (a) The Customer Indemnifies farmsupplies.net.au against any loss or liability arising out of:
- (1) Any breach by the Customer of the terms, or
- (2)Negligence on the part of the customer or any person for whom the customer is responsible.

(3)

Passing of Risk and Retention of Title.

- (a)Risks in the goods will remain with farmsupplies.net.au until the goods depart farmsupplies.net.au.

8.0Default.

- 1. Default
- (a)Payment will immediately become due and the Customer's right to possession of the goods will cease if the customer;
- (1) Fails to make payment of the goods.
- (2)Commits a breach of any of these terms.
- (3)Commits an act of bankruptcy, is declared insolvent, passes a resolution for winding up, has petition presented against it for winding up, has an administrator, receiver, liquidator or other insolvency practitioner appointed in respect of it or its assets, or enters into an arrangement, compromise or assignment for the benefit of the creditor.
- (b) If an event set out in clause 8 (1) occurs, farmsupplies.net.au may without prejudice to it other rights and remedies;
- (1)Withhold any further deliveries of goods.
- (2)Suspend or terminate performance of any other contracts which farmsupplies.net.au has with the Customer.
- (3)In respect of goods already delivered, enter onto the premises of, or under the Customers control, without liability for trespass or any resulting damage, and retake possession of the goods in which legal and beneficial title is held at farmsupplies.net.au, and;
- (4)Institute legal proceedings to recover the Customers debt including recovery of related costs, expenses and outgoings (including legal fees on a solicitor/client Basis).
